

A \$1,000 award will be given to a dietetics educational program accredited/approved by the Accreditation Council for Education in Nutrition and Dietetics (ACEND[®]), Academy affiliate, dietetic practice group, member or interest group or other recognized Academy group in recognition of past accomplishments to successfully recruit and retain diverse individuals.

ACADEMY IDEA STATEMENT

The Academy encourages inclusion, diversity, equity and access (IDEA) by striving to recognize, respect and include differences in ability, age, creed, culture, ethnicity, gender, gender identity, political affiliation, race, religion, sexual orientation, size, and socioeconomic characteristics in the nutrition and dietetics profession.

QUALIFICATIONS

- a. Applicant is an Active category member of the Academy of Nutrition and Dietetics from an ACEND[®] accredited/approved dietetics educational program, Academy affiliate, dietetic practice group, member interest group or other recognized Academy group.
- b. Application focuses on the successful recruitment, retention and/or leadership development of an underrepresented community as outlined by the Academy’s IDEA Statement.
- c. Award recipient agrees to share program/project information with Academy as requested.

OVERVIEW OF AWARD

- a. A \$1,000 award will be provided per year to an ACEND[®] accredited/approved dietetics educational program, Academy Affiliate, dietetic practice group, member interest group or other recognized Academy group.
- b. The award may not be given multiple times to one group for the same program.

SCORING CRITERIA

Grant reviewers will use the following criteria when scoring applications. Check your application prior to submission to ensure all areas are addressed.

Use the following criteria when scoring each application. For each section, select a single number, with 1 as a low score, on each criterion scale. 1-3 represent poor criteria alignment, 4-7 represent average criteria alignment, and 8-10 represent strong criteria alignment. (100 points total)
