Important Definitions

- **I-20 Forms:** Also known as “Certificate of Eligibility”; document issued by a U.S. educational institution that certifies an international student’s eligibility to apply for an F-1 student visa.
 - While some universities do not provide the I-20 forms for international students, the university may still accept students who have already obtained an I-20 form. Additionally, while some universities may distribute the I-20 forms, it is possible the program may not accept international students as this depends on program-specific policies. Please contact the program director of the program you are interested in to learn more about the application process.
- **International Credential Evaluation/Foreign Degree Evaluation Report:** A generated report from a foreign degree evaluation agency used to validate U.S. educational equivalency of higher education degree(s). For a list of agency types, please click [here](#).
- **International Students:** Refers to anyone who lives outside of the U.S. and its territories, interested in pursuing higher education in the U.S. with a valid student visa. Note: this does not refer to individuals who are U.S. citizens or permanent residents.
- **Prior Assessed Learning (PAL) Policy:** A program- specific policy regarding an evaluation that grants credit or hours of experience for content or skills that the student/intern has previously mastered.
