
PRESIDENT REPORT BOARD OF DIRECTORS MEETING MAY 11-12, 2023



It has been a tremendous honor to serve you as Academy President in the past year. Together as a Board of Directors and staff we have accomplished a great deal and moved the Academy's mission, vision and strategic plan forward. To all of you who are completing your Board service, I extend my gratitude and sincere thanks for your dedication, service and courage. Thank you in particular to Kevin Sauer for setting such a remarkable example for me to follow as President, and my best wishes and full support to Lauri Wright as she becomes our 2023-2024 President.

Following are activity highlights since our April 2023 meeting.

Members Honored for Professional Achievements

Academy members Mary Lee Chin, MS, RDN; Barbara Millen, DrPH, MPH, RD, LND, FADA; and Johanna Rohler, MBA, RD, were honored by Purdue University's College of Health and Human Services for their professional achievements.

Action Alerts Advocating for the Profession

Action alerts were created and shared with all practitioners in April on two legislative priorities:

- <u>The Senior Hunger Prevention Act (S. 1036)</u> would ensure older adults, grandparents, kinship caregivers and adults with disabilities are able to access food. Portions of the bill would streamline paperwork, help get food to people and increase resources.
- The Special Diabetes Program funds research on the prevention and cure of Type 1 diabetes. The program is administered by the National Institute of Diabetes and Digestive and Kidney Disease, in collaboration with multiple National Institutes of Health departments and the Centers for Disease Control and Prevention. Congress must take action to ensure funding continues for this critical program before it expires at the end of September.

Increasing Utilization of MNT through Health Insurance Benefit Design

The Nutrition Services Coverage team continues to forge partnerships with insurance entities including the Office of Personnel Management, which oversees the Federal Employee Health Benefits, and the insurance broker Brown and Brown. The Academy works with both organizations, providing guidance on the utilization of MNT in benefit plans. Developing partnerships is vital to advance the goal of increasing consumer access to RDNs and nutrition services care for both chronic disease prevention and management.

Medicaid Mapping Project

Work continues on the Academy's mapping project with George Washington University to identify MNT coverage in each state Medicaid program. The main deliverable consists of a spreadsheet that includes a summary; state-by-state comparison table of language found by domain; language extracted during the review; and links to regulatory provisions, provider manuals, coverage policies and provider portals. Academy staff meets with GW biweekly to review updates on the project, document progress, discuss

challenges encountered and make recommendations for modifications. As of April 20, this project is on track to have all states analyzed and peer reviewed through the contract period.

Weekly Office Hours: Licensure and Payment and Reimbursement

The PIA team hosts weekly office hours to answer members' questions. Licensure office hours are held on Wednesdays, from 1 p.m. to 2 p.m. (Central time) with staff answering questions on state licensure requirements or consumer protection and professional regulation issues. For questions on payment, reimbursement or coverage for nutrition services, Academy members are encouraged to join the payment and reimbursement office hours on Wednesdays from 2 p.m. to 3 p.m. (Central time). No registration is required.
