INCLUSION, DIVERSITY, EQUITY AND ACCESS (IDEA) MINI-GRANTS



Inclusion, Diversity, Equity and Access (IDEA) Leaders, charged with promoting the nutrition and dietetics profession and Academy membership to underrepresented groups, are encouraged to submit applications for IDEA mini-grants to help fund diversity outreach initiatives and cultural humility programs in their affiliate, dietetic practice group (DPG) or member interest group (MIG), such as presenting at high school career fairs or hosting a cultural humility course. The Academy's IDEA Committee reviews each application and awards the recipients.

ACADEMY IDEA PHILOSOPHY

The Academy recognizes, respects and includes differences in ability, age, creed, culture, education, ethnicity, gender, gender identity, geographic region, language, lived experiences, mental health, military experience, national origin, political affiliation, race, religion, sexual orientation, size, socioeconomic characteristics, values, work experiences and all types of diversity in the nutrition and dietetics profession.

OUALIFICATIONS

- a. Applicant is an IDEA Leader for an Academy affiliate, DPG or MIG.
- b. Applicant is a member of the Academy holding any membership category except Student, International Student, Honorary and Associate. Those with the following membership categories can apply to become an IDEA Leader: Active, Retired, Returning Student and International.

OVERVIEW OF PROGRAM

- a. IDEA Leaders on file with the Academy are eligible to submit one application annually, on behalf of their Academy Groups, for an IDEA Mini-Grant.
- b. Grant funds can be used to complete existing projects or rolled into the next fiscal year if proposed activities have not been completed at the time of funding.
- c. The link to submit nominations will be sent to IDEA Leaders in November 2023.
- d. Deadline to apply for an IDEA Mini-Grant is March 1, 2024.
- e. By submitting an application, the IDEA Leader agrees to complete a follow-up survey.
- f. Applicants will be notified of application status in spring 2024.
