Dear Chairwoman Capito, Ranking Member Baldwin, Chairman Aderholt, Ranking Member DeLauro, Chairman Hoeven, Ranking Member Shaheen, Chairman Harris, and Ranking Member Bishop,

On behalf of the following 215 national, state, and local organizations who support patients and families impacted by eating disorders, we urge you to address the increasingly critical public health issue of eating disorders in the United States. Unfortunately, no community is spared from the devastating impact of this serious mental illness including our service members, veterans, and youth. As you begin to work on the Fiscal Year 2026 (FY26) Labor, Health and Human Services, and Education (LHHS) and the Agriculture, Rural Development, Food and Drug Administration and Related Agencies (Ag-FDA) Appropriations bills, we ask that you consider three requests within the FY26 LHHS and Ag-FDA bills.

Approximately 30 million Americans suffer from a clinically significant eating disorder during their lifetime.¹ Eating disorders cost \$65 billion annually and experts estimate that only one in ten people receive treatment.² These conditions have the second highest mortality of any mental illness, and every 52 minutes a life is lost as a direct result of an eating disorder.³ No group is spared the devastating effects of an eating disorder, including our pediatric populations. Unfortunately, research has shown a doubling in

eating disorder emergency room admissions for adolescent females and rising increase of pediatric mental health emergency room visits.^{4,5} These conditions can have lifelong health impacts on children if not identified early or prevented.

The Substance Abuse and Mental Health Services Administration (SAMHSA), the Office on Women's Health (OWH) within the Office of the Assistant Secretary of Health (OASH) and the Food and Nutrition Service (FNS) all play critical roles in monitoring eating disorder prevalence and enhancing access to early intervention and prevention to keep families whole and healthy.

The following three bipartisan, bicameral requests aim to support cost-effective policies to support your constituents impacted by eating disorders and their families.

Labor, Health, and Human Services

SAMHSA

In 2018 under the 21st Century Cures authorization, SAMHSA created the Center of Excellence for Eating Disorders (ED-CoE) to provide training for health professionals to screen, briefly intervene, and refer patients to specialty care. Bipartisan efforts in Congress reauthorized the ED-CoE within the *Consolidated Appropriations Act, 2023* (P.L.117-328) to continue early detection and intervention for eating disorders with a focus on the pediatric population. The agency has identified that public awareness activities are complimentary to its current work and a priority to enhance understanding of this mental illness within the general population. Acknowledging the impact SAMHSA has made on eating disorders prevention and recovery, the U.S. House Appropriations Committee provided \$5 million to support Eating Disorders Prevention in the Fiscal Year 2025 (FY25) LHHS appropriations report. As part of this work, the funding request includes for SAMHSA to continue its work training providers and conduct a public service announcement to better reach Americans impacted by an eating disorder so they can seek help.

For this reason, we urge the inclusion of funding and report language for the ED-CoE to continue provider training and significantly improve eating disorder identification, treatment and recovery for at risk populations including veterans, service members, and pediatric populations.

Eating Disorders.— Eating disorders will impact 30 million Americans in their lifetime and cost the United States \$64 billion annually. Between 2019-2022, emergency department visits for adolescent females doubled with higher levels of acuity. The Committee supports SAMHSA's work to address eating disorders amongst Americans, especially youth. The Committee provides \$5,000,000 to improve the availability of health care providers to respond to the needs of individuals with eating disorders including the work of the National Center of Excellence for Eating Disorders to increase engagement with primary care providers, including pediatricians, to provide specialized advice and consultation as related to the screening, brief intervention and referral to treatment of eating disorders, as authorized under the Consolidated Appropriations Act of 2023 (PL-117-328). The committee directs SAMHSA to conduct a public service announcement on eating disorders to educate on the best practices to identify, prevent, and treat, an individual with an eating disorder. The Committee requests a report within 180 days of the enactment of this Act on the status of the public awareness campaign.

Office on Women's Health-OASH

While eating disorders occur in both men and women, females are at higher risk. In response to the alarming rise in eating disorders amongst adolescent females, the Office on Women's Health awarded \$1,000,000 in discretionary grants in 2022 to Washington University in Saint Louis, Missouri, and George Mason University in Fairfax, VA, to improve early detection and prevention of eating disorders in adolescent girls.⁶ Washington University developed a screening and detection protocol designed specifically for at-risk adolescent girls, through which they trained 690 health professionals and screened more than 1,300 girls for eating disorders.⁷ George Mason developed training materials for clinicians for improved detection and assessment of bulimia nervosa risk factors and symptoms – they trained 107 community-based mental health providers on improved recognition of eating disorders and trained an additional 99 community-based clinicians and school counselors in 2024.⁸ In FY24 and FY25, the committee provided \$750,000 for eating disorder research to improve early intervention in eating disorders to help with recovery to support this work. We thank the Committee for including \$750,000 in FY25 for eating disorders research under the Office of the Assistant Secretary of Health (OASH). This funding will continue to support early detection of eating disorders amongst women and girls to support recovery.

For these reasons, we urge you to include the following funding and report language request for research for women and girls to support early detection, prevention, and treatment of eating disorders.

Eating Disorders Research. — The Committee remains concerned that women and girls are at heightened risk for developing an eating disorder during their lifetime. The Committee recognizes OWH's efforts to address the rise in eating disorders amongst adolescent girls. The Committee continues the funding of \$750,000 for eating disorders research and urges a focus on early detection and treatment protocols for women and girls with or at-risk of developing an eating disorder to help reduce long-term health care expenditures and disease acuity. The Committee encourages OWH to prioritize projects to address the lack of pediatric and adolescent screening in the primary care and pediatrics settings. The Committee urges OWH to coordinate with outside organizations, eating disorders specialists, and other groups as necessary to identify research needs of eating disorders amongst women and girls.

Agriculture

Food and Nutrition Service

The Local School Wellness Policy (LSWP) requirement was established by the *Child Nutrition and WIC Reauthorization Act of 2004* and further strengthened in 2010. Each local educational agency participating in the National School Lunch Program and/or School Breakfast Program must develop a LSWP that addresses physical activity, nutrition, and childhood obesity. Given the current adolescent mental health crisis, the current structure of LSWPs that solely address physical activity and nutrition education does not provide a comprehensive approach to the wellbeing of students. We thank the House and Senate Subcommittees on Agriculture, Rural Development, FDA, and Related Agencies for including language to update LSWP's to include "eating disorders education and prevention" in their reports in FY25.

For these reasons, we urge the inclusion of the following report language in the FY26 Agriculture Appropriations report.

Local School Wellness Policies.—The Committee acknowledges that difficulty accessing a variety of foods can cause significant issues, including poor physical health and eating disorders. The Committee directs the Secretary to update local school wellness policy guidance to incorporate eating disorder prevention and education into the existing local school wellness policy framework. The Committee requests a report within 120 days of the enactment of this act on the agency's progress to update State Education Agencies on the inclusion of eating disorders education and prevention within Local School Wellness Policies.

We'd like to thank the committee for its support of eating disorders policy and research in previous fiscal years. Strong bipartisan support for eating disorders prevention, policy, and research will allow for lifesaving efforts for millions of your constituents and their families. We look forward to working with you in FY26 to bolster this support, which will make a profound difference for the millions of Americans and their families impacted by eating disorders.
