\*Known issue with AU 2023 logic. Calculations presented in this row represent logic and measure intent. Current logic allows for the Nutrition Assessment to count even if the Malnutrition Risk Screening Result is Not at Risk, providing a calculated score of 2/1 or 200% if the Nutrition Assessment was done. If a Nutrition Assessment is not performed when the Malnutrition Risk Screening Result is Not at Risk, the score will be 1/1 or 100%.
